Narrative

The Story County Sheriff's Office received a call from a Casey's employee in Maxwell at approximately 0404 hours on April 24, 2014. She reported that a man walked to the store claiming to have been in a car accident south of town, and he was injured. When I arrived, medical personnel were already on scene.

Robert Jones reported that he was driving around looking at deer. He was westbound on Hwy 210, turned around, and he headed back east towards Maxwell. He was watching deer too closely, and he left the roadway. He claimed he was only driving 25-30 miles per hour, he was wearing his seat belt, and his airbags did not deploy. He also claimed to have lost consciousness for a moment and stated that the vehicle did not roll.

I observed Robert was bleeding profusely from his nose and he had a cut above his left eye. It appeared as though he had hit his face pretty hard. He also had lacerations on his right hand. He was transported to Story County Hospital by ambulance.

I located the vehicle in a field north of Highway 210. According to the scene, it appeared as though the vehicle was northbound on 650th Ave and went straight through the T intersection. The vehicle sustained front end damage when it struck the ditch embankment. A street sign for Hwy 210 and 650th Ave was torn down and Robert continued to drive over 100 yards in the field before he stopped in the mud. In addition to the front end damage, the driver's side front tire

was flat. No airbags deployed. The driver seat belt was not locked extended and there was blood on the steering wheel and driver seat.

A stop ahead sign and stop sign were in place at this intersection. A double arrow warning sign was present on the north side of this intersection. The arrow warning sign appeared to be in poor condition, but it was still visible. Iowa DOT was contacted by Story County Dispatch.

The vehicle was secured and left for the time being upon request of Robert and with permission of the property owner.

I met with Robert at the Story County Hospital. I explained to him what I observed on the scene and he did not believe that he went through an intersection or that he was on 650th Ave. He then commented about maybe turning around in someone's drive. I provided him with a report number and instructed him to call the Sheriff's Office to provide his insurance information, as I did not find insurance in the vehicle.

Charges are pending.
