

DRAINAGE MINUTES  
JOINT DISTRICTS BOONE #109-STORY #5 & BOONE #196-STORY #9  
MAY 25, 2022

The Boone and Story County Drainage District Trustees met via Zoom in the Boardroom of the Boone County courthouse in Boone, IA to consider levies against Joint Drainage Districts Boone #109-Story #5, Story County Controlling and Boone #196-Story #9, Boone County controlling (see attached levy sheets). Members present were Latifah Faisal, chair, Linda Murken, and Lisa Heddens from Story County and Stephen Duffy, chair, Erich Kretzinger, and Bill Zinnel from Boone County. Also present virtually were 5 entities identified by full name, a single name, initials, or a phone number.

Duffy called the meeting to order at 8:35 a.m.

Kretzinger moved, seconded by Heddens, to approve the agenda. Motion carried unanimously (MCU).

Duffy stated there was a recommendation to levy Joint Drainage District Boone #196-Story #9, Boone County controlling, at 21.5% of its original assessed value.

Zinnel moved, seconded by Faisal, to approve the recommended levy against Boone #196-Story #9, said assessment to be due and payable on or before September 30, 2022. MCU.

Faisal stated there was a recommendation to levy Joint Drainage District Boone #109-Story #5, Story County controlling, at 24% of its original assessed value.

Kretzinger moved, seconded by Murken, to approve the recommended levy against Boone #109-Story #5, said assessment to be due and payable on or before September 30, 2022. MCU.

Kretzinger moved, seconded by Heddens, to adjourn. MCU. Meeting adjourned at 8:39 a.m.
